BIGG - BOSS 14 - CONTESTANT SE POOCHO SAWAAL ("Contest") Terms and Conditions

These Terms and Conditions ("Terms and Conditions") are applicable for the Contest (as defined below) that is organized and hosted by Viacom18 Media Private Limited (hereinafter referred to as "Viacom18") in relation to the Program "Bigg Boss- Season 14" (hereinafter referred to as "Program") primarily to be aired on Viacom18's channel namely 'Colors' (hereinafter referred to as "Channel") and Viacom18 has agreed to host and promote the Contest on its Channel (to the limited extent mentioned herein), whereby Participants can participate in accordance with the Terms and Conditions contained hereinbelow.

- 16. Viacom18 or the authorized representative of Viacom18 shall intimate the Caller at any time/in any manner as deemed fit by Viacom18, on the email address/phone number provided by him/her during the time of the registration of the Contest, to confirm that he/she has been selected as the Caller and accordingly shall confirm his/her acceptance. If the Caller fails to confirm his/her acceptance of the Gratification for any reason including but not limited to not responding within the time frame mentioned in the email communication, and/or refusing to accept the Gratification and/or refusing to provide details as required by Viacom18, in such a case, Viacom18 shall have the right to disqualify such Caller and reselect another Participant in place of him/her as the Caller. In such event the Participant/Caller is not entitled to claim any right or demand or benefit or damages or monies

- or compensation from Viacom18. Any claim/damage/demand/compensation for the same will neither be entertained nor compensated by Viacom18.
- 25. Employees or relatives of Viacom18 and/or their associate and affiliate companies/ concerns will not be qualified for any participating in the Contest.
- 26. The Participants hereby agree that some Personal Information ("PI") of the Participants will be collected by Viacom18 to enable to administer and promote this Contest and the Participant hereby consents to an unrestricted usage of the PI thereof. In case Viacom18 collects any PI of the Participants at any time during the Contest, then it shall be responsible to ensure protection of such PI as collected by Viacom18.
- 27. The Participants shall be responsible to additionally provide such information as may be required by Viacom18 for the purpose of granting the Gratification. - 31. It is hereby expressly stated all intellectual property in the audio/video questions of the Participants shall belong solely and exclusively to Viacom18 in perpetuity and Viacom18 may exploit the same in any manner at its sole discretion. The Participant(s) hereby also agrees and confirms that any and all revenue or benefit arising from such exercise and/or exploitation of the audio/video footages and/or questions shall solely vest with Viacom18 and the Participant(s) shall have no right in such revenue or benefit nor shall claim any title nor create any dispute of whatsoever nature. It is agreed that Section 19(4) of the Copyright Act, 1957 shall not apply to any assignment of rights contained herein.
- 32. The cost accompanied/arising from the Gratification and/or expenses of any nature, shall be borne solely by the Participants and no monies will be reimbursed nor can be claimed from Viacom18.
- 33. Viacom18 shall not be liable for any loss of earnings, employment or otherwise caused to the Participants or their parents or legal guardians or legal heirs even if such loss arises as a result of his/her being declared as the Caller of this Contest.
- 34. The Participants agree and confirm that by registering to participate in the Contest, Participants are expressly consenting to receive acknowledgment/ messages about the Contest from Viacom18 and/or its authorized representative.
- 35. The Participants shall neither question such process nor dispute the same in any manner.

- 38. The Caller shall be intimated directly in any manner, as deemed fit by Viacom18. Viacom18 shall not entertain and shall not be answerable to any questions, correspondence, enquiries on the manner of conduct of the Contest including but not limited to the grant of the Gratification, mode and manner of the enjoyment of the Gratification.
- 39. The Participants and Caller shall comply with all the terms and conditions associated with the Contest, including but not limited to the Terms and Conditions mentioned herein and associated with Gratification.
- 40. The Participants / the Caller is not entitled to assign its rights and obligations arising from his/her participation in the Contest to any third party for any reason whatsoever however Viacom18 is entitled to assign its rights and obligations with respect to the Contest to any third party/entity without any further notice to the Participants / the Caller.

Viacom18 shall not be liable for any performance of these Terms and Conditions in the event of force majeure (such as natural disasters, acts of the government including any regulation or order of Government of India or any State Government or any statutory or judicial authority, network attack, system error, etc.).

The Terms and Conditions as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. - 45. These Terms and Conditions shall be construed in accordance with the laws of India and incase of any dispute or any other matter arising in reference to the registration shall be subject to the exclusive jurisdiction of the Courts in **Mumbai** only.
